

Endowment Funds

The R.H. Purnell Fund – established for the needy without restrictions. A standing committee directs the use of this fund.

The Eliza A. Judd Fund – established for assisting those in need who are either church members, their immediate families or employees of the church. The Purnell Committee also directs this fund.

The Mamie C. Russell Fund – established for foreign missions.

The Nellie C. McIver Fund – established for foreign and home missions.

The Bernard Greenewald Fund – established for benevolent purposes including scholarships for ministerial students and retirement funds for former staff members. A standing committee directs the use of this fund.

The Julia H. Lucas Fund – established for benevolent purposes for residents/citizens of the State of South Carolina.

The Park Fund – established to provide interest-free loans to students.

The J.W. Allen Fund – established for local Presbyterian causes.

The James McCutchen Fund – established to support the mission work of the church, both foreign and domestic.

The Dr. John E. Williams Music Scholarship Fund – established to assist students pursuing musical studies.

The Ruby West Malphrus Endowment Fund – established for any need within our church or outside of our church at the discretion of the Session, with the restriction that no funds can be used for the operating budget.

The BSA Fund/Erwin and Freeman Memorials – established to provide a source of financial assistance for the benefit of the Boy Scout Troop of the Church or any successor Boy Scout Troop, the Spartan District and the Palmetto Council.

The McGee Family – established on the basis of the first five hundred dollars of income is for foreign missions, the balance to a needy ministerial student from the church.

The Edward T. and Ada W. Spires Mission Fund - established for Benevolent and Mission causes both locally and throughout the world with approval of the Session.

The Thomas Joy Glenn Fund - established for the purchase of a Communion table for the Sanctuary, the continued preservation of the Sanctuary and Chapel, and any other church purposes as designated by the Thomas Joy Glenn Family.

The Keith Youth Benevolent Fund - established to provide for youth, ages 13-20, for activities, field trips and/or emergency needs.

The Perrin Fund - established for maintenance, replacement, additions, service, and repairs of the Paccard bells.

The Scott Family Fund – established to assist individuals in need, primarily in our local community.

The Marshall Chapman Fund – established to support Presbyterian missions or Institutions.

The Burris Fund – established primarily for the health and general welfare of those in need in the church then community.

The Paul F. and Louise F. Holcomb Fund – established to be used for local benevolent Purposes.

The Lula Abercrombie Fund – established for use for building and facilities maintenance.

The Floy and Philip Cecil Fund – established to support the Youth Ministry.

The Penn Music Fund – established to support ecclesiastical music in our worship or in special programs.

The Penn Recreation Fund – established to support the recreation programs and recreation facilities of First Presbyterian Church.

The Wall Family Fund – established for support of mission start-up projects, domestically and internationally.

The Lou Bomar Thomson Fund – established for special facilities projects or additions to the facilities.
